Policy Document for Scholarship and Free ship

Purpose

The students in Swa. Sawarkar Mahavidyalaya, Beed come from the diverse rural backgrounds and socio-economic conditions. The student's academic achievements have to be empowered. It is identified by the college that one of the reasons of dropout in higher education is weak economic condition of the students. To overcome the issue, the college follows the approach of inclusivity and offers scholarships and free ship to students viz. GOI (ST, SC, SBC, OBC, NT etc.), Rajarshee Shahu Shikshan Shulk- EBC, Central Sector National Scheme, Post Metric Minorities Scholarships, Post Metric Minorities Scholarships disabilities. The policy document is an outline for the effective distribution of scholarship and free ship is prepared here for information.

Scope

The policy is applied in general to the students of Swa. Sawarkar Mahavidyalaya, Beed by extending scholarship and free ship assistance to fill up the financial gap. This support inculcates the sense of belongingness and motivates the students to complete their higher education.

Policy Statement

The college processes scholarship and free ship applications on fulfilling the required eligibility norms given in the prospectus of the college.

- 1. The college will extend scholarship and free ship to students who are from economically weak background but sincerely desire to study and work for the nation.
- 2. The college will extend administrative support to apply for scholarship free ship.
- 3. The college will maintain a record of the beneficiaries under various financial support schemes.
- 4. The college will have monitoring mechanism for the effective communication with the students
- 5. The scholarship section will look after the timely approval of scholarship and fee ship amount by the government.
- 6. The management also give concession to the students time to time who belongs to economically weaker sections, who are supported under these schemes.



Responsibilities

- 1. The Principal will take the responsibility of getting approvals to these schemes.
- 2. The Office Superintendent along with the section clerk will be responsible for ensuring the process of disbursing the amount.

The Record Management

- 1. The detailed documents relating to the scholarship and free ship support scheme (like order of sanction by the government, form of the scheme, student ID, Bank account no. etc) will be preserved by the Clerk appointed for the scholarship section.
- 2. The information along with necessary documents of Scholarship and Free ship will be shared the with the IQAC Coordinator annually.
